We asked for people to put themselves forward to help with future plans at the special meeting held in January 2019, and we had a fantastic response. We were able to set up a separate Shop Development Committee who have done absolutely amazing work in researching and progressing ideas and enabled us to get to our current position, more on that very shortly.

Running alongside them we now have our Fundraising Committee who has shown a staggering amount of enthusiasm and creativity. Indeed we raised around £9,000 last year for the Save Wilstone Shop fund through the things like amazing items produced by the Wilstone Woolies, the SOCK appeal, raffles at film nights and the coin jar in the shop, plus events such as last year's Open Village, the Sing Wilstone concert and the Live 'n Local event last December. We have also several very generous personal donations. Our very grateful thanks to everyone who has been involved or donated, it has been heart warming indeed.

Thanks to each and every one of you; we have our moments of crisis but you always come up trumps and you are at the core of why our customers love us.

Volunteering is well recognised as an important contributor to personal wellbeing so it's a win win all round.

Announcing our plans for the future has seen a real outpouring of support from not just people in our parish but from everyone involved with us and that has been truly heartwarming and helps give us the strength to push forward towards our end goal.
